## COURSES TAUGHT AT THE U.S. NAVAL WAR COLLEGE

## In the core:

**Policy Analysis, National Security Decision-Making.** A survey course for the senior students (pursuing the MA in national security studies) which examines the U.S. national security policy process, key domestic and international influences, and introduces different foreign policy analysis theories of decision-making.

**Security Strategies, National Security Decision-Making**. A survey course for the senior students which provides an introduction to international relations theory, the principal school of thought about international affairs, a survey of U.S. interests in key regions of the world, and an examination of the principal strategic documents of the U.S. government.

**Policy Analysis, Theater Security Decision-Making.** A survey course for the intermediate students (pursuing an MA in strategy) which examines how the U.S. government subdivides responsibility for theater security issues to organizations within the national security apparatus, both in Washington and in the "field", and examines how policy is supervised both by the Executive and Legislative branches.

## **Electives:**

**Geopolitics of Eurasia.** A course examining the security dilemmas of Russia and other states in Eurasia, and the interactions of the Eurasian states with the major powers and regional groupings of the world. An especial focus of the course was to compare and contrast the Ukrainian and Kazakh approaches to geopolitics.

**Geo-economics.** A course providing a general overview to the concept of geo-economics and the major economic tools available to states to shape their geopolitical environment. The course also provided an introduction to the working of sovereign wealth funds and focused on different projects related to the "New Silk Road" and "One Belt/One Road" initiatives.

## **COURSES DEVELOPED:**

**Russian Foreign Policy.** An upperclass undergraduate/graduate course designed to give an overview of the major trends and developments in contemporary Russian foreign policy, including Russia's interaction with its neighbors, the major powers, and the international system. Versions taught at Brown University, Georgetown University and George Washington University.

**History of the Cold War**. An upperclass undergraduate/graduate course that provides an introduction to the Cold War, the origins of the struggle, the impact on the national security establishment of the United States, and the major developments from 1945-1991.

**Religion, Identity and Empire.** A small-group interdisciplinary seminar designed to examine the interplay between religious, ethnic and national identities in Eastern Europe and Eurasia in both historical and contemporary settings, with an eye to assessing how fixed or fluid such markers for individual and group identity. Taught at Georgetown University; a version was also adapted for George Washington University.

**Paradox of Power and Justice.** A course designed for upperclass honors undergraduates, to probe the relationships—actual and normative—between the requirements of "justice" (as often laid down by "the church") and the role and responsibilities conveyed by the exercise of "power" (often epitomized by "the state"), in both theory and practice. Competing assertions of social responsibility and individual liberty, and the historical conflicts arising from them, are also examined, in a variety of cultural contexts. Taught at Baylor University.

**Eastern Perspectives on Church and State.** A graduate interdisciplinary seminar to examine the theory and practice of "church-state" relations from the "Eastern" perspective, both Christian and non-Christian, as manifested in the policies and practices of Japan, the Chinese Empire, India, the Muslim world, the Byzantine (East Roman) Empire, the Mongol Empire, and medieval Russia, and their implications for modern times. Taught at Baylor University.

**International Human Rights.** An upperclass undergraduate course to examine both the various philosophical theories of human rights as well as the definitions and types of rights (social, political, civil, economic, and collective) as codified by major international treaties, and to examine how they are implemented in the contemporary global system. Taught at Baylor University.

(American) Civil Religion. A graduate interdisciplinary seminar to examine the theory, history, development, organization, and rituals of civil religion, primarily as practiced in the United States.

**History of Church and State in the West.** A graduate interdisciplinary seminar to examine the history of church-state relations in Western societies from the Roman Empire to the Enlightenment.

# **COURSE RANGE**

Instruction offered in general history (world civilization, European History 1450-present, Russian history, U.S. History), specialized aspects of Russian and Eurasian history and culture, politics, international relations and security studies and in general politics (international relations, international human rights, East European politics and society). Experience in developing interdisciplinary courses drawing upon history, politics, philosophy, and religion.
